INTRODUCTION

The Union Marine & General Insurance Co., Ltd. received its Certificate of Incorporation on 15 January 1863, and commenced business in Liverpool on 2 February 1863. The company was based on a merger between Charles Langton & Co. and Rawson, Aikin & Co. A London office was opened in 1864. In 1893 the company took over the International Marine Insurance Co., Ltd. In 1911 the company merged with the Phoenix Co., a general insurance firm. In 1931 the firm changed its name to the Union Marine & General Insurance Co., Ltd. In 1905 the firm moved into new headquarters, the Union Marine Buildings at 11 Dale Street, Liverpool. The company is still trading and is based in Horsham, West Sussex.

For a published history of the firm, see B/UM/G/2/1 (1913) and B/UM/G/2/2 (1963).

The collection comprises accounts, agency records, board files, claims records, investment valuations and staff records, and covers the years 1845 - 1986.

The collection is stored in our off-site store and is accessible by *appointment only*. Please contact the Maritime Archives & Library for details. Some of the collection remains uncatalogued. Further company records can be found in the Bryson Collection, reference D/B/177.

The National Maritime Museum also holds records of the company, and their reference is UMN.
