Ogwr District Council was formed in 1974 under the Local Government Act 1972 taking on the functions of Bridgend Urban District Council, Porthcawl Urban District Council, Maesteg Urban District Council, Ogmore and Garw Urban District Council and Penybont Rural District Council.
