#### **The Graig Shipping Co. Ltd./PLC, Cardiff**

With associated companies : Idwal Williams and Co., The Glynafon Shipping Co. Ltd., Garth Shipping Co. Ltd., and Lisvane Investment Co. Ltd.

The Graig Shipping Co. Ltd. was established in October 1919 by Idwal Williams (1884-1971) of Cardiff in conjunction with the directors of two colliery companies, a spark plug manufacturer, and a shipping butcher. The company was initially placed under the leadership of C.E.M. James (colliery director), G.E. Williams (director for shipping butchers) and Idwal Williams. Idwal Williams and Co. Ltd. later took over management.

Many of the companies' records were damaged or destroyed by fire at the Graig Co.'s offices in Merthyr House, Cardiff Docks, in 1945. The records listed below were deposited in the Glamorgan Record Office in 1995 (accession number 1995/59) and 1997 (1997/74). Accession references are placed in [ ].
