### CONTEXT

Administrative/Biographical history: The Maes-yr-haf Settlement (Trealaw, Rhondda, Glamorgan) was established following emergency relief operations organised by the Society of Friends (Quakers) in the Rhondda valleys during the 1926 coal strike. While organising the distribution of clothing and food in the Rhondda, several prominent Quakers, including Emma Noble, of Swindon, Wiltshire, became convinced of the need for a more permanent form of help to the area. Through the autumn and winter of 1926-1927, the idea rapidly developed to establish a Quaker Social Settlement. A large Victorian house, Maes-yr-haf, was purchased at Trealaw, near Tonypandy. The first Wardens of the Settlement, William and Emma Noble of Swindon, moved into Maes-yr-haf in April 1927; they were to remain there until 1945. As direct relief work, distributing food and clothing, came to an end, the Maes-yr-haf Settlement developed as an educational and social centre. The Settlement ran a wide range of classes for the unemployed, from 'moral philosophy' to more practical boot repairing centres. The settlement's activities expanded to include drama, music, and running a holiday camp for the unemployed at the Malthouse, Wick, Glamorgan. A ttempts were made to promote small-scale employment opportunities in the Rhondda, including, at Maes-yr-haf allotments, poultry farming, and pottery and weaving workshops. Maes-yr-haf Industries for the Disabled, between 1944 and 1957, provided employment for the local disabled, producing furniture, and, later, mineral water boxes. Following the Second World War, the standard of living in the Rhondda Valleys improved dramatically, and responsibility for educational and social services was increasingly transferred to the state. By the late 1960s, the committee felt that many of the original objectives of the Settlement had been achieved, and that it was appropriate for the management of the Maes-yr-haf Settlement site to be transferred to the local authority. After discussions between Glamorgan County Council, Rhondda Borough Council and the Maes-yr-haf Committee, the Settlement site was purchased in 1971 by the Rhondda Borough Council. The capital from the sale was used to establish the Maes-yr-haf Educational Trust, which annually distributes its income among the organisations associated with the Settlement. The Maes-yr-haf site serves as a community centre, used by many organisations, such as the Play

Group and Women's Institute, which developed during the period of the Settlement.
