### **Administrative/biographical history**

Rail Passengers' Committees developed out of Transport Users Consultative Committees (1947-1994) established at nationalisation of the rail network in 1947 as representative bodies of passengers on trains under the overall supervision of the Central Transport Consultative Committee. On rail privatisation in 1993, the committees were replaced by the Rail User Committee (RUCC) network with the Central Rail Users Consultative Committee (CRUCC) as coordinating body. The network campaigned for improvements in the Passenger's Charter, establishment of Disabled People's Protection Policies, and minimum levels of service provided by franchisees. In 2000 the Transport Act created the Strategic Rail Authority and formalised the change of name to Passengers Council and Committees. The SRA's key role was to promote and develop the rail network and to give direction over matters such as fares, quality of service, overcrowding and complaints. Seven regional authorities for England and two national bodies for Wales and Scotland became part of the statutory framework co-ordinated by the Rail Passengers Committee (based in London) under the sponsorship of the SRA with the function of protecting and promoting the interests of rail passengers.

The collection comprises minutes and general administrative filing of the Rail Passengers Committee (Wales).
