## CONTEXT

**Administrative/Biographical history:** The Institute of Chartered Accountants in England & Wales was incorporated by Royal Charter in May 1880. The national body oversees District Societies covering the regions. The Incorporated Accountants and Auditors formed the South Wales and Monmouthshire Society of Incorporated Accountants, founded in 1894. The Institute of Chartered Accountants' South Wales and Monmouthshire Society of Chartered Accountants was formed in 1914. The Incorporated Accountants and Auditors, South Wales and Monmouthshire District Society, was dissolved and merged with the South Wales and Monmouthshire Society of Chartered Accountants in 1958. It changed its title to South Wales Society of Chartered Accountants in 1975.

**Scope and content/abstract:** Records of the South Wales Society of Chartered Accountants, 1911-1982, including: meeting and Annual General Meeting minutes books, 1911-1958; committee meeting minutes books, 1926-1954; minutes of general meetings, 1913-1952; minutes of annual general meetings and committee meetings, 1953-1982; minutes of committee meetings, 1947-1953; and minutes of the Joint Library and Tuition Committee of the South Wales and Monmouthshire Society of Chartered Accountants Students' Society, 1913-1938.
