### **Administrative/biographical history**

Mike Glover is a retired architect who started off working in private practice but later moved into local government service, being employed by Glamorgan, Mid Glamorgan and finally South Glamorgan County Councils. At South Glamorgan he had special responsibility for Cardiff Airport and Dyffryn House.

### **Archival history**

The records have been collected by Mr Glover, many of which were acquired during his service in local government.

### **Immediate source of acquisition**

Parts of the collection were deposited in 1996, 2001, 2005 and 2008 by Mr Glover.
