Administrative History:

The Research Committee was one of the first Committees it's inaugural meeting convened by R J F H Pinsent on 29 March 1953 was only four months after the foundation of the College. This meeting discussed the opening of a research register, a research advisory panel and plans were started towards an investigation into the use of sulphonamides and antibiotics in the prevention of measles. First steps towards a National Morbidity Survey were considered and the introduction of a Research Newsletter was decided upon to foster contacts between members. Faculties were encouraged to set up their own research committees.

The Research Newsletter first appeared in September 1953 in the pages of The Practitioner. By 1956, it was being published quarterly and was made available to the general public at a cost of 3s 6d per copy but was free to College members. The Research Newsletter evolved, into The Journal of the College of General Practitioners [later BJGP] and "Between Ourselves" was created. This was a new internal circular which became a clearing house for research ideas.

A College classification of diseases was published in 1959. To set standards for research and to enable data to be centrally analyzed and converted to computer punch cards the "E" book [named after its inventor Tev Eimerl] a diagnostic index was invented and later a "Age-Sex Register.

An Epidemic Research Unit was founded by Ian Watson in 1954 [See ARE Research Unit Records 1954-1998]

Plans for the collection of national morbidity statistics in general practice were

initiated in 1953 and involved discussions with the Registrar General's Department and the Chief Medical Statistician. A questionnaire to identify practice profile was prepared and record cards designed. A pilot was undertaken in February 1955 and the project started on 1st May 1955 with 108 practices covering a population of 400,000. Material was coded according to the International Classification of Diseases and analyzed by the Registrar General's Department. Three further national morbidity studies were undertaken.

In 1962, a Research Foundation [later Scientific Foundation Board SFB] was started to help provide funding for research projects.

The Research Department, founded in 1966, became the Clinical & Research Division in 1988. The Research Committee became the Coordinating Group for Research in 2001. In 2006, the Department was restructured to create the Clinical Innovation and Research Centre (CIRC) which also included the Research Units [See ARE]. Some of the Clinical Task Groups - e.g. Health Inequalities, Rural Affairs were moved to the Central Secretariat i.e. Policy & Governance

March 1980 Report from Research Division Executive "Dr Kay reported that the Executive had agreed draft guidelines for the conduct of clinical trials in practice, which had been drawn up by Dr Drury; it had been discovered that both BMA and ABPI had drafted similar reports and he wished Council's approval for overtures to be made to the other two bodies in order that one statement could be issued on behalf of all three organisations.

June 1980

Dr Drury spoke to his paper (1980C/29). He explained that the Honorary Secretary had written to the DHSS giving the Colleges views. There were still some points where the BMA Ethical Committee and the College did not agree; for instance, the BMA wanted the committees to be formed at district level but the College felt that the expertise required for these trials would have to be found at regional level. Discussion had taken place at the Liaison Committee with the GMSC the previous day and he believed some progress had been made. It was pointed out that the College was not the appropriate body to assess cases; this should be one which included lay representatives. It was also considered that clinical trials should clearly be shown to be of clinical benefit to patients.

In 1980, Council approved the establishment of this committee in order to provide ethical guidance of protocols for clinical trials in general practice. The primary reason for this was that the College was in the process of promoting such trials itself by means of its own research institution, the Medical Surveillance Organisation. It recognised that in most cases such studies needed to be done within a number of districts, regionally or nationally, and that the process of submitting a protocol to a number of local Ethical Committee could be confusing. It was also seen however that an individual doctor involved in a study that had contract approval might quite properly wish to have a particular existing local problem scrutinised by the local committee, but that they would be able to accept the "general" ethical acceptability of the proposals. A second situation was that this committee would plug the holes where there was no local ethical committee.

The committee was established with Sir Eric Scown as Chair. In 1982, it was recognised by the DHSS as a properly constituted committee for the purpose of the exemption from licenses (clinical trials) order 1981. It started to take on cases outside those of the MSO and in 1985 the GPC supported the idea that the committee to cover a wider range of activities than clinical trials.

In 1989, Sir Michael Drury took over the chairmanship and the committee remit was widened to consider protocols other than drug trials and the name changed to Clinical Research Ethics Committee.

The Committee was formally disbanded in 1996 when the NHS Committees on Clinical Research were set up.
