

Eccles Old People's Welfare Association was established in 1946 according to an account of its activities in Eccles and Patricroft Journal, 5 Feb., 1981 (A/TR301). These activities included the promotion of the first over-60s clubs in Eccles (Winton, Patricroft, Eccles, Rowallan). The Association in addition set up hostels for the aged: Derby House, 19 Ellesmere Road, Eccles, M30 9HP, Da Vinci House (opposite Derby House) and Orchard House, Victoria Road. It also built a "Daily Club" as a day centre for the elderly, situated in St. Mary's Road near St. Mary's Church on land leased by Eccles Borough Council.

The City of Salford Social Services Department took over the distribution of meals on 2 Dec., 1980, and in Jan., 1981, took back the lease of the site of the "Daily Club" near St. Mary's Church, Eccles. The Association was formally dissolved in 1981.
