The Eccles and District Owner-Occupiers' Association had the purpose of taking care of the varied interests of owner-occupiers in the district. It made representations locally to government departments, local authorities and other bodies on such matters as health, postal and transport services, etc., and nationally on such matters as rates, town planning, etc. It offered to members free advice on income tax matters and free financial and legal advice. It was wound up at an annual general meeting held in 1980, described as its 30th annual general meeting.

This Association was affiliated with the Manchester and District Owner-Occupiers' Federation (later the Greater Manchester and District Owner-Occupiers' Federation) and the National Federation of Owner-Occupiers' and Owner-Residents' Associations (also referred to as the National Federation of Owner Occupiers' Associations).
