The Salford Empire Settlement Committee was set up in 1929 to help, especially in view of the number of unemployed young people, persons wishing to settle in other parts of the British Empire. The minutes of a meeting on 15 April, 1930, note a decision that, as recruiting for the next six months was suspended, the Committee should raise funds to help local people for whom work had not been found and especially likely migrants to other parts of the country. In 1931 the Committee merged with the apparently already existing Home Settlement Committee to form a new Committee under the title of the Salford Empire and Home Settlement Committee. There are some remarks on the history of the Salford Empire Settlement Committee and the Salford Empire and Home Settlement Committee in U54/TC4. According to U54/F1 the Mayor of Salford's Emigrants' Fund was incorporated in the Salford Empire Settlement Committee.

The City Treasurer of the time was appointed the Hon. Treasurer in 1929. The following records formed the complete contents of a box (marked "Central filing system: static files:70") found among the City Treasurer's records. In 1966 this charity was amalgamated with others under the name of the City of Salford Relief of Distress Fund.
