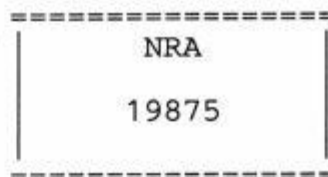

Adey and Son giving reasons for sale of the Stow Hill Baptist Church (£8,500), copies of minutes of meetings, arrangements for use of classrooms at the Gaer and St. Julian's schools also correspondence relating to insurance cover for the new church and a legacy from estate of J.
