1. 1911-1915 LETTER BOOK of the St. George's Steamship Co., Ltd., Conway.
2. 1915-1919 LETTER BOOK of the St. George's Steamship Co. Ltd., Conway.
- 3-11. 1911-1919 Correspondence between Griffiths, Keeling and Sherwood, Council Chambers, 109 Colmore Row, Birmingham, chartered accountants, and J.W. Post, Esq., Secretary, St. George Steamship Co. Ltd., Conway:
3. 1911 Nov. 14 LETTER: Griffiths, Keeling and Sherwood to J.W. Post, Esq., returning the Fire Policy with the Ocean Accident Co. (policy not present). As the question of Profit and Loss debits is one of analysis, they take it that the Company's Directors have gone into the fairness of the additional charge of £12.11s.5d. to coal and oil to the relief of materials, and are therefore noting the alteration.
4. 1912 Nov. 1 LETTER: Griffiths, Keeling and Sherwood. to J.W. Post, Esq.. They have checked the Company's books which appear to be in order. They would like to see the share ledger and have a statement of wages paid weekly to each employee, the statement to be initialled by the person paying the wages which they believe to be Capt. Roberts. Asks if all the accounts to the 31st October have been paid and put through the books.

5. 1914 Nov. 5 LETTER: Griffiths, Keeling, Sherwood and Co., Ltd., to J.W. Post, Esq., acknowledging receipt of his letter and parcel of books enumerated therein. Asks for Minute Books written up to date.
6. 1915 June 4 LETTER: Griffiths, Keeling, Sherwood and Co., to J.W. Post, Esq.. They are making a claim for re-payment of Income Tax on behalf of Mr. C.M. Lees and the Inland Revenue require a certificate re payment of tax to them by the St. George Steamship Co.. Asks for enclosed form to be signed and returned.
7. 1915 Nov. 5 LETTER: Griffiths, Keeling, Sherwood and Co., to J.W. Post, Esq., apologising for having been unable to audit the company's book due to shortage of staff. They have a new man commencing on the following week and the books will be returned immediately. Tells the Secretary not to have the accounts printed until the audit is complete, and apologises to the Directors for the delay which has been unavoidable.
8. 1916 Jan. 10 LETTER: Griffiths, Keeling, Sherwood and Co., to The St. George Steamship Co. Ltd., re Finance Acts under the Income Tax and Excess War Profits Duty recently passed and with which provisions they are making themselves conversant in order that they, as the Company's accountants, may be able to advise them on any points that may arise so that they may not lose sight of the various benefits that can be obtained if applied for. Lists some interesting points.
9. 1917 Nov. 1 LETTER: Griffiths, Keeling, Sherwood and Co., to J.W. Post, Esq., acknowledging receipts of letter, together with Bank Pass Book, Rough Report and other books for audit which they hope to return within a few days.

10. 1918 Oct. 28 LETTER: Griffiths, Keeling, Sherwood and Co., to J.W. Post, Esq., H. Keeling had hoped to get to Conway for a few days holiday, but it is doubtful whether he shall now be able to come to Conway before Christmas. If Mr. Post goes to Birmingham asks him to call in the office any days except Wednesdays or Saturdays.
11. 1919 Feb. 20 LETTER: Griffiths, Keeling, Sherwood and Co., to J.W. Post, Esq.. They are preparing a claim for repayment of Income Tax on behalf of Mr. C.M. Lees. Asks for a form to be filled, signed and returned to them as the Inland Revenue requires a Certificate.
- 12-22. 1911-1919 Correspondence between J.H. Dunkerley, Haven House, Moorside, Oldham and J.W. Post, Secretary of the St. George Steamship Co., Ltd., Conway:
12. 1911 Nov. 15 LETTER: J.H. Dunkerley to Mr. J.W. Post, asking for balance of the Company's Shares at the death of Mr. Pollitt, for probate purposes.
13. 1912 Nov. 1 LETTER: J.H. Dunkerley, to J.W. Post, acknowledging letter and proof Balance Sheet. He notes the profit is nearly 9% and that the Company have rightly increased the depreciation by 1%. It would suit him better to have the General Meeting on a Saturday morning if that is agreeable to the other Directors.
14. 1913 Nov. 23 LETTER: J.H. Dunkerley to Mr. Post, acknowledging bill for taxes and queries whether this should not have been paid by the Company. In his district all taxes on Directors' fees are paid by the Companies. He had almost received the bill before being appointed Chairman.

15. 1914 April 18 LETTER: J.H. Dunkerley to Mr. Post, He returns the cheque, duly signed. He will send him his account for tax on Monday and agrees that both their accounts should be paid out of the balance in hand. He had been to Conway on the day before but did not have time to call on Mr. Post. He saw Capt. Roberts and looked round the steamers. The boilers are quite safe should the Board of Trade inspector come down on Monday to inspect them.
16. 1915 May 20 LETTER: J.H. Dunkerley to Mr. Post asking him to attend to enclosure. Asks if the date of the first sailing has been fixed.
17. 1914 Oct. 15 LETTER: J.H. Dunkerley to Mr. Post returning cheques, duly signed, Sat., Oct. 31st would suit him better than Oct. 24th, and asks if this can be arranged. Also asks for result of the Season's Work.
18. 1914 Oct. 26 LETTER: J.H. Dunkerley, to Mr. Post, asking him to fix a meeting for November 2nd, as it is impossible for him to attend, before that date. Asks for rough proof of balance sheet. As the General Meeting was held last year on Nov. 15th, asks if a meeting could be held on Nov. 14th this year.
19. 1917 Sept. 1 LETTER: J.H. Dunkerley to Mr. Post, apologising for not being able to visit him again. Asks him how the steamers go on, and how the receipts keep up.
20. 1918 Oct. 16 LETTER: J.H. Dunkerley to Mr. Post acknowledging his letter and notes his intention of trying to arrange a meeting for 26th. He will be going to Harrogate on Friday but shall be coming home on the 21st. Mrs. Pollitt went on Monday to Harrogate to spend a week with them. Asks if it is true that Capt. Roberts received an additional £10 to his Directors fee of £5. He would like to know the amount of his salary, also Capt. R. Roberts' for the season. He supposes that the £10 for Capt. Roberts is as Managing Director.

21. 1919 Sept. 10 LETTER: J.H. Dunkerley to Mr. Post. Asks for particulars of The St. George and for him to write to P.N. Witter Esq., Knowsley Buildings, Chapel Street, Liverpool and give him the particulars. He does not know what price they quoted the other firms but is inclined to ask more as prices of everything are so high. Asks for a copy, but the condition must be that they did not run her up the Conway river.
22. 1919 Sept. 14 LETTER: J.H. Dunkerley to Mr. Post, acknowledging letter and copy sent to Mr. Witter. He notes that there is no mention about a price for St. George in it and asks him for particulars of quotation.
