NEW TESTAMENT: Society for Promoting Christian Knowledge. This Testament was used in the Court until its closure. The Testament has many inscriptions: 'Llangefni Petty Sessions, 14 January 1822, Inspector Parry' 'Panton Arms Petty Sessions, 1844', 'Menai Bridge Petty Sessions, 3 June 1889', '1893', 'Menai Bridge Police Court, 23 October 1895'.

METAL LOCKABLE FILE BOX: [The box was seen by the depositor behind the Bench from the early 1970s until the court was closed in April 1993 [last sitting there was December 1992]. As no key was found the lock was forced before deposit].

The box contains forms for the various processes administered by the Magistrates' Court and a list of the contents is on the door of the box. The forms cover the 1840s-1900s but most are for 1880s-1900s. Some forms were printed locally but some are national forms.
