Sir John de Cotesdene kt., gave in frank marriage to Margery his daughter and John, son of Sir Ralph de Camoys kt., the manors of Elyng and Hasham, and the advowson of the church of Hasham (except the lands of divers tenants which Sir John had reserved the lives of himself and his wife) to have and to hold to the said John Camoys and Margery

his wife and the heirs of their bodies, remainder to the right heirs of Sir John de Cotesdene.

The agreement was made the day after St. Matthew's day 44 H. III. [22 Sept. 1260]

[Note: The Rev. W.H. Gunner suspected the authenticity of this document on the grounds that Margery [or Margaret] was only 4 years old in 1260, since she is described as 13 years in the writ ante Noid. and unmarried in 53 H. III. Better as it may Margaret de Cotesdene established her title to the manor in 17 Edw. I after the death of her husband John Camoys. v. Misc. 22 = 6189 Kirby]

A Roll of memoranda made for the use of Counsel for the College in the action, tried at Winchester in 1406, whereby Sir Thomas Camoys claimed and sought, but unsuccessfully, to recover the manor of Eling, which the Founder had purchased from Henry Husee, and had conveyed and warranted to the College.

In consequence of the Founder's P.T.O.

warranty, the College cited his heir, Alice Perot, and her husband, to appear in the action and vouch the College title to the Manor. Hence the pedigree of Wykeham on the back, needed to show that the proper parties had been cited. This pedigree differs from the received one, in making Fitz not Champneys, the name of the husband of Agnes, Wykeham's sister.

Summary of Wykeham's title to the manor,
and observations on objects to it.

(Another copy of No. III 6 = 6141)

The manor was granted by King John to Emma
de Staunton, widow, remainder to her daughter Cecilia,
and the heirs of her body. After Emma's death the
manor was confirmed to Cecilia in 11 H. III. [1227].
She dying seized the manor descended to her son
heir Matthew Husee, who did homage for it in P.T.O.

20 H. III [1236]. In 52 H. III [1271] Ralph de Camoys
levied a fine of it to Robert Walerand - his heirs,
but how Ralph de Camoys came to be seized of it
is unknown. Robert Walerand granted the lands to
which he held by the gift of Ralph de Camoys to his
nephew, Alan le Plokenet, & the heirs of his body,
but it is not known whether the manor of Eling
was included in the grant, or whether Alan le
Plokenet died without issue. In 5 Edw. III [1330/1]
Ralph de Camoys granted the manor to his son
Hugh, but it is not known by what means he
became possessed of it. Sir Henry Husee, great
grandson and heir of Matthew Husee, brought an

In 19 Edw. III [1345] he granted the manor to
Hugh de Camoys for life. Thomas de Camoys,
Hugh's eldest brother, released his interest to
him in 43 Edw. III [1369]. Then Henry Husee,
as son & heir of the Henry Husee who recovered
the manor in 16 Edw. III [1342] granted it for life
to Hugh de Camoys, and granted the reversion
O.T.N

after Hugh de Camoy's death to Wykeham, to whom he levied a fine with warranty in 46 Edw. III [1372] Hugh de Camoy then surrendered his life estate to Wykeham, & Henry Husee, by deed dated 20 May 47 Edw. III [1373] enrolled in Chancery, released his interest as heir at law to Wykeham. Wykeham afterwards granted the manor to the Warden & Scholars - clerks and they are now in possession.
